

# URBANA CITY COUNCIL PUBLIC HEARING TUESDAY, DECEMBER 18, 2018

President Hess called the City of Urbana Public Hearing to order to consider the rezoning of the Scioto Street Plaza PUD (10.032 acres) (parcels: #K48-25-11-02-28-013-00 & #K48-25-11-02-28-013-01). The applicant AVCAP Urbana LLC on behalf of Mario Kiezi, is requesting the parcels be rezoned from Planned Unit Development (PUD) to B-2 General Business District.

Adam Moore advised that the applicant wanted to revoke the current PUD and rezone Scioto Street Plaza to B-2. Mr. Moore stated that it has been before the Planning Commission, and the commission recommends approval to revoke the PUD in whole.

#### **ORDINANCE 4437-18**

AN ORDINANCE TO AMEND RESOLUTION 2433-17 TO MODIFY OR INCREASE APPROPRIATIONS WITHIN VARIOUS FUNDS OF THE CITY OF URBANA, OHIO FOR CURRENT EXPENSES DURING THE FISCAL YEAR ENDING DECEMBER 31, 2018. (SUPPLEMENTAL APPROPRIATIONS) (Suspension of Rules Requested)

Mrs. Boettcher went through the departments of the City and explained whether the funds within the departments needed to be increased or decreased. The total for the supplemental appropriations is in the amount of \$1,058,175.00.

Mr. Thackery moved to suspend the three reading rule. Mr. Paul seconded. President Hess called for a roll call for the suspension of rules: Mr. Huffman, yes; Mr. Paul, yes; Mr. Scott, yes; Mr. Thackery, yes; Mr. Pena, yes; Mr. Piper, yes; and Mr. Fields, yes.

Mr. Thackery moved to put this ordinance on the floor for discussion and possible passage. Mr. Paul seconded. President Hess called for a roll call for passage: Mr. Paul, yes; Mr. Scott, yes; Mr. Thackery, yes; Mr. Pena, yes; Mr. Piper, yes; Mr. Fields, yes; and Mr. Hoffman, yes;

Ordinance passes 7-0.

#### ORDINANCE NO. 4486-19

AN ORDINANCE TO AMEND SECTION 171.013 OF THE CODIFIED ORDINANCES TO ADD AN ADDITIONAL SIX-TENTHS OF ONE-PERCENT (0.6%) TAX ON INCOME TO THE CURRENT ADDITIONAL FOUR-TENTHS (0.4%) TAX RATE, ESTABLISHING THE NEW ADDITIONAL TAX RATE AT ONE-PERCENT (1.0%) (Sponsored by Councilman Dwight Paul)

Mr. Brugger stated that if passed, this would be put back on the ballot at the next election which would be in May, 2019. He also added that if passed, it must be passed no later than 2-6-19 or 2-27-19, to be placed on said ballot. He stated that a resolution would also come following the passage, if passed. Additionally, he added that if the voters passed the new tax rate, it would be in effect July 1, 2019.

President Hess declared this ordinance to have its first reading

#### RESOLUTION NO. 2383-18

RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO THE 2019-2021 HOUSING REVOLVING LOAN FUND ADMINSTRATION AGREEMENT WITH THE OHIO DEVELOPMENT SERVICES AGENCY (GRANTOR) AND THE CITY OF URBANA (GRANTEE).

Mr. Crabill said that the State of Ohio requires this agreement to be in place.

President Hess called for a roll call for passage: Mr. Scott, yes; Mr. Thackery, yes; Mr. Pena, yes; Mr. Piper, yes; Mr. Fields, yes; Mr. Hoffman, yes; and Mr. Paul, yes.

Resolution passes 7-0.

#### MISCELLANEOUS BUSINESS/WORK SESSION

Mr. Bumbalough stated that there were two change orders referencing the sewer line for the school. He stated that the initial cost was higher than expected.

Mr. Brugger advised that the salt trucks were ready to go. He also stated that the Compost Facility is now closed. He said that the Wreaths across America project was a success. He advised that the Airport project was coming along. He also stated that the year 2018 was a very busy year and that he believes 2019 to be another busy year. He also thanked Council for all of their support through the year and looks forward to next year.

Mayor Bean also commented on how 2018 was a busy year and looked forward to next year as well. He also stated that the DAR did an excellent job with the Wreaths across America project. He stated that there were over 600 wreaths placed at Oakdale Cemetery and approximately 100 people were present. He added that it was a wonderful experience being there.

President Hess spoke about the Charter Review Committee. Council Clerk Deere advised that she would provide the updated potential committee list to Council.

Mr. Fields moved to adjourn. Mr. Paul seconded. Voice vote on approval: all ayes, nays, none. Motion passes 7-0.
