TO ALL CHAMPAIGN COUNTY MUNICIPALITIES

Substitute Senate Bill 52 took effect on October 11, 2021, which included new wind and solar siting legislation and provided authority for boards of county commissioners to restrict the location and size of large-scale wind and solar facilities in all or parts of a county. In reviewing this legislation, the Champaign County Board of Commissioners desires to conform this authority with the growth and development of residential and commercial interests, as set forth in the recent county comprehensive plan adopted, that may be inconsistent with the location of large-scale wind and solar facilities. The Board of Commissioners has broad authority to restrict large scale wind and solar facilities within the county and as such are looking at providing a buffer zone around the municipalities in the county in order to allow reasonable and necessary residential and commercial growth that would also preserve farmland. The Board of Commissioners intends to designate restricted areas of the county but will provide statutory notice and public hearing prior to passing the designating resolution.

RESOLUTION LEVYING AN ADDITIONAL FIVE DOLLAR (\$5.00) PERMISSIVE MOTOR VEHICLE LICENSE TAX IN CHAMPAIGN COUNTY, OHIO

THE BOARD OF COMMISSIONERS of Champaign County, Ohio met in regular session June 23, 2022 with the following present:

Bob Corbett Tim Cassady Steve Hess

WHEREAS, pursuant to *Ohio Revised Code* Section 4504.24, the Champaign County Commissioners are permitted to enact an additional five dollars (\$5.00) permissive motor vehicle license tax for the planning, constructing, improving, maintaining, and repairing of public roads, highways, streets, bridges, and viaducts within Champaign County, Ohio. The additional annual tax is at the rate of five dollars (\$5.00) per motor vehicle where the district of registration is located within Champaign County, Ohio. The additional five-dollar permissive motor vehicle license tax is expected to generate \$230,000 thousand per year; and,

WHEREAS, pursuant to *Ohio Revised Code* Section 4504.24, public hearings were held by the Board of Champaign County Commissioners on June 16, 2022, and June 23, 2022 to hear any persons who may have an interest in the proposed levying of an additional five dollars (\$5.00) motor vehicle license tax for the purposes outline in the above referenced section of the *Ohio Revised Code*. Notice of the Public Hearings were published in a newspaper of general circulation, *Urbana Daily Citizen*, on May 24, and 31, 2022. At the hearings, Mr. Stephen McCall, Champaign County Engineer, provided an overview providing the need for the additional five dollars (\$5.00) permissive license tax; and,

WHEREAS, pursuant to Section 4504.24 of the *Ohio Revised Code*, the Clerk of the Board shall provide notice of the adoption of the resolution to the legislative authority of each municipal corporation in Champaign County, Ohio, and to the Board of Township Trustees of each township in Champaign County, Ohio; and,

WHEREAS, pursuant to Section 4504.08 of the *Ohio Revised Code*, the Clerk of the Board shall certify a copy of this resolution to the Champaign County Engineer, who shall forward a copy to the Ohio Bureau of Motor Vehicles; now therefore,

BE IT RESOLVED by the Board of County Commissioners, Champaign County, Ohio, that:

<u>Section 1.</u> This Board, pursuant to Section 4504.24 of the *Ohio Revised Code*, hereby determines that it is necessary to levy an additional county motor vehicle license tax.

<u>Section 2.</u> That an additional annual motor vehicle license tax is hereby levied pursuant to Section 4504.24 of the *Ohio Revised Code*, which is in addition to any tax levied pursuant to Sections 4503.02, 4503.07, and 4503.18 of the *Ohio Revised Code* and any other relevant tax levied under this title of the *Ohio Revised Code*. The additional annual motor vehicle license tax shall be at the rate of five dollars (\$5.00) per motor vehicle in the district of registration which is Champaign County, Ohio. The rate shall be in addition to the taxes specified in Sections 4503.04 and 4503.16 of the *Ohio Revised Code*.

<u>Section 3.</u> This Board finds and determines that all formal actions of this Board concerning and relating to the adoption of this resolution were taken in an open meeting of this Board and that all deliberations of this Board that resulted in those formal actions were in a meeting open to the public in compliance with the law.

Section 4. This resolution shall be in full force and effect thirty days following its adoption.

AN ORDINANCE ADOPTING THE TAX BUDGET OF THE CITY OF URBANA, OHIO, FOR THE FISCAL YEAR BEGINNING JANUARY 1, 2023; SUBMITTING THE SAME TO THE COUNTY AUDITOR. (Three (3) readings and public hearing required. Public Hearing Advertisement date: Friday, June 10, 2022).

Department Requesting: Finance Sponsor: Dwight Paul

WHEREAS, the Mayor has prepared a tentative Tax Budget of the City of Urbana, Ohio, for the fiscal year beginning January 1, 2023, showing detailed estimates of all balances that will be available at the beginning of the year 2023, for the purposes of such year and of all revenues to be received for such fiscal year, including all general and special taxes, fees, costs, percentages, penalties, allowances, and other types of classes or revenues; also, estimates of all expenditures or changes in or for the purpose of such fiscal year to be paid or met from the said revenues or balances; and otherwise conforming with the requirements of law, and;

WHEREAS, said Tax Budget has been made conveniently available for public inspection for at least ten (10) days prior to adoption, by having at least two (2) copies on file in the office of the Director of Finance, and;

WHEREAS, this Council has held a Public Hearing on said Tax Budget of which public notice was given in accordance with law, and;

WHEREAS, the necessity of providing for the usual daily operations of the various municipal departments, requires that this resolution be in effect no later than July 15, 2023, and;

WHEREAS, this resolution shall take effect and be in force immediately upon approval by the Mayor as provided by Section 2.15 of the Charter of the City of Urbana, Ohio.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Urbana, County of Champaign and State of Ohio:

Section One.

That the Tax Budget of the City of Urbana, Ohio for the fiscal year beginning January 1, 2023, heretofore prepared by the Mayor and submitted to this Council, copies of which have been and are on file in the office of the Director of Finance, be and it is hereby adopted as the official Tax Budget of the City of Urbana, Ohio for the fiscal year beginning January 1, 2023.

Section Two.

That the Clerk of Council is authorized and directed to certify two copies of said Tax Budget and a copy of this Ordinance and to transmit the same to the Auditor of Champaign County, Ohio on or before July 20, 2022.

Section Three.

That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of its committees, if any, which resulted in formal action were taken in meetings open to the public, in full compliance of all applicable legal requirements, including ORC Section 121.22

ORDINANCE NO. 4574-22

AN ORDINANCE AMENDING THE EXEMPTION PERIODS OF URBANA COMMUNITY REINVESTMENT AREA 1 AS ESTABLISHED BY CITY ORDINANCE NO. 4348; REPEALING CITY COMMUNITY REINVESTMENT AREA NO. 4; AND REPEALING NORTH MAIN STREET COMMUNITY REINVESTMENT AREA (Three (3) readings and public hearing required. Public Hearing Advertisement date: Friday, June 10, 2022).

Department Requesting: Community Development Sponsor: Councilman Pat Thackery

WHEREAS, the council (the "Council") of the City of Urbana, County of Champaign, State of Ohio (the "City") desires to pursue all reasonable and legitimate incentive measures to assist and encourage development in specific areas of the City that have not enjoyed reinvestment from remodeling or new construction; and

WHEREAS, Council passed Ordinance 4348 in 2010, establishing Urbana Community Reinvestment Area 1 ("Urbana CRA- Area 1"), designated as CRA #021-04356-01 by the State of Ohio Department of Development; and

WHEREAS, Council amended Ordinance 4348 ("Ordinance 4348 as Amended") on February 11, 2011 to expand the geographic boundaries of Urbana CRA-Area 1, designated as CRA #021-79072-01; and

WHEREAS, the designation of Urbana CRA- Area 1 has rendered certain ordinances establishing Community Reinvestment Areas within the City obsolete; and

WHEREAS, under the terms of Ordinance 4348 as Amended, remodeling and new construction projects within Urbana CRA-Area 1 may qualify for tax exemptions on the increase of assessed valuation of the improvements to real property for under the Community Reinvestment Area ("CRA") Act, Ohio Revised Code ("O.R.C.") Sections 3735.65 through 3735.70; and

WHEREAS, the Council has determined that it is in the best interests of the City to amend the periods of available tax exemption in order to provide the City with the most available economic development tools to further encourage redevelopment in Urbana CRA- Area 1.

NOW, THEREFORE, BE IT ORDAINED by the City of Urbana, County of Champaign, State of Ohio, that:

Section One.

That Section 4 of Ordinance 4348, as Amended, is deleted in its entirety and replaced with:

"Within the Community Reinvestment Area, the percentage of the tax exemption on the increase in the assessed valuation resulting from improvements to commercial and

industrial real property and the term of those exemptions shall be determined or negotiated, where applicable, on a case-by-case basis in advance of construction or remodeling occurring according to the rules outlined in O.R.C. Section 3735.67. The results of the negotiation as approved by this Council will be set in writing in a Community Reinvestment Area Agreement as outlined in O.R.C Section 3735.671. For residential property, a tax exemption on the increase in the assessed valuation resulting from the improvements as described in ORC Section 3735.67 shall be granted upon application by the property owner and certification thereof by the designated Housing Officer for the following periods:

- a. Fifteen (15) years, for the remodeling, or new construction, of every residential dwelling containing not more than two family units and upon which the cost of remodeling is at least \$2,500, as described in ORC Section 3735.67 and with such exemption being one hundred percent (100%) for each of the fifteen (15) years.
- b. Fifteen (15) years, for the remodeling, or new construction, of every residential dwelling containing more than two family units and upon which the cost of remodeling is at least \$5,000, as described in ORC Section 3735.67 and with such exemption being one hundred percent (100%) for each of the fifteen (15) years.
- c. Up to, and including, fifteen (15) years, and up to, and including, one hundred percent (100%) for the remodeling of existing commercial and industrial facilities, the term and percentage shall be negotiated on a case-by-case basis in advance of the remodeling occurring as evidenced by legislative action by this Council authorizing a CRA Agreement pursuant to ORC Section 3735.671.
- d. Up to, and including, fifteen (15) years, and up to, and including, one hundred percent (100%) for the construction of new commercial and industrial facilities, the term and percentage shall be negotiated on a case-by-case basis in advance of the construction occurring as evidenced by legislative action by this Council authorizing a written CRA Agreement pursuant to ORC Section 3735.671.

If remodeling qualifies for an exemption, during the period of exemption, the exempted percentage of the dollar amount of the increase in the assessed valuation of the existing structure shall be exempt from real property taxation. If new construction qualifies for an exemption, during the period of exemption, the exempted percentage of the assessed value of the structure shall be exempted from real property taxation. In the case of residential, commercial, and industrial remodeling or construction, the tax exemption shall first apply in the year the remodeling or new construction would first be taxable but for the exemption. In the case of residential remodeling or new construction, the owner of a dwelling may file an application with the Housing Officer at any time, including after the year the construction or remodeling first became subject to taxation. If an application submitted after the year the construction or remodeling first became subject to taxation is approved, the exemption sought in the application first applies in the year the application is filed. No

exemption may be claimed for any year in that period that precedes the year in which the application is filed. Applications now pending but not yet approved by the City, may be amended by the owner to request the full period authorized by this Ordinance."

Section Two.

That Section 6 of Ordinance 4348, as Amended, is deleted in its entirety and replaced with:

"To administer and implement the provisions of this Ordinance, the City Director of Administration or his, or her, designee is hereby designated as the Housing Officer, with those duties as described in ORC Sections 3735.65 through 3735.70."

Section Three.

That all other Sections of Ordinance 4348, as Amended, remain in full effect.

Section Four.

That Community Reinvestment Area No. 4, Codified Ordinances of the City of Urbana Chapter 1333 Sections 1333.08 through 1333.14, is hereby repealed.

Section Five.

RESOLUTION NO. 2634-22

A RESOLUTION TO AUTHORIZE FINAL APPROVAL BETWEEN THE CITY OF URBANA, CHAMPAIGN COUNTY, OHIO AND OHIO DEPARTMENT OF TRANSPORTATION FOR PAVEMENT PLANING AND RESURFACING OF UNITED STATES ROUTE 68 FROM JUST SOUTH OF PEARCE PLACE (SLM 5.36) TO WASHINGTON AVENUE (SLM 6.93), OMITTING THE ROUNDABOUT AT US 36, Reference PID No.: 108874, County/Route/Section: CHP US 68 5.36, AND DECLARING AN EMERGENCY (one reading required).

Department Requesting: Engineering Sponsor: Councilman Cledis Scott

WHEREAS, the City of Urbana, hereinafter referred to as the LPA, and the State of Ohio have determined the need for the described project:

The project consists of resurfacing the existing roadway of US 68 from SLM 05.36 (0.07 mile south of Pearce Place) to SLM 06.93 (Gwynne Street/Washington Avenue), excluding the roundabout at US 36 and US 68. This work also includes pavement repair and pavement markings, lying within the City of Urbana; and

WHEREAS, on the 18th day of January, 2022, the LPA enacted preliminary legislation proposing cooperation with the Director of Transportation; and

WHEREAS, the LPA shall cooperate with the Director of Transportation in the above described project as follows:

The City agrees to assume and bear one hundred percent (100%) of the entire cost of the improvement within the city limits, less the amount of Federal-Aid funds set aside by the Director of Transportation for the financing of this improvement from funds allocated by the Federal Highway Administration, U. S. Department of Transportation.

The share of the cost of the LPA is now estimated in the amount of One Hundred Eighty Thousand Four Hundred Two and - - - 00/100 Dollars, (\$180,402.00), but said estimated amount is to be adjusted in order that the LPA's ultimate share of said improvement shall correspond with said percentages of actual costs when said actual costs are determined; and

WHEREAS, The Director of Transportation has approved said legislation proposing cooperation and has caused to be made plans and specifications and an estimate of cost and expense for improving the above described highway and has transmitted copies of the same to this legislative authority; and

WHEREAS, The LPA desires the Director of Transportation to proceed with the aforesaid highway improvement.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Urbana, County of Champaign and State of Ohio:

SECTION ONE:

That the estimated sum, of **One Hundred Eighty Thousand Four Hundred Two and ---- 00/100 Dollars**, (\$180,402.00) is hereby appropriated for the improvement described above and the fiscal officer is hereby authorized and directed to issue an order on the treasurer for said sum upon the requisition of the Director of Transportation to pay the cost and expense of said improvement. We hereby agree to assume in the first instance, the share of the cost and expense over and above the amount to be paid from **Federal** funds.

SECTION TWO:

That the LPA hereby requests the Director of Transportation to proceed with the aforesaid highway improvement.

SECTION THREE:

That the LPA enter into a contract with the State, and that the **Director of Administration** be, and is hereby authorized to execute said contract, providing for the payment of the LPA the sum of money set forth herein above for improving the described project.

SECTION FOUR:

That the LPA transmit to the Director of Transportation a fully executed copy of this Resolution.

SECTION FIVE:

All actions of City Council related to this legislation were conducted in open meetings pursuant to Urbana Codified Ordinance 107.01 and Ohio Revised Code 121.22.

SECTION SIX:

This ordinance shall become effective on the 5th day of July, 2022.
