1. City of Urbana Shade Tree Commission Minutes of November 14, 2020. (See attached)

Board of Control

- 1. The Board of Control recommends that Council authorize the Director of Administration to enter into a loan agreement/loan account with Ohio EPA, DEFA for a WSRLA loan to fund the water portion of the Phase 2A Water and Sanitary Replacement. Council previously passed Resolution #2544-20 to apply for, accept, and enter into this loan agreement/loan account. This Board of Control action finalizes the terms of this loan for this portion of the project. The total loan amount is \$1,610,333.12 at 1.18% interest for 20 years (40 total payments) with the final cost of borrowing, including interest being \$1,812,543.60. The first payment will be due January 1, 2022 with payments due in January and July of each calendar year. Each payment will be \$45,313.59. This debt will be repaid by water rates (see attached exhibit). **VOTE: 3-0**
- 2. The Board of Control recommends that Council authorize the Director of Administration to enter into a loan agreement/loan account with OWDA to fund the sanitary sewer portion of the Phase 2A Water and Sanitary Replacement. Council previously passed Resolution #2580-20 to apply for, accept, and enter into this loan agreement/loan account. This Board of Control action finalizes the terms of this loan for this portion of the project. The total loan amount is \$366,037.88 at 1.93% interest for 10 years (20 total payments). The first payment will be due January 1, 2022 with payments due in January and July of each calendar year. This debt will be repaid by sewer rates.
- 3. The Board of Control recommends Council authorize a purchase order to Hull and Associates, Inc. in the amount of \$49,095.00 for Task Order #15 to finalize all environmental consulting work for the east side of the Q3 JMC property. This task order includes budget overages incurred due to the NFA letter not being able to be submitted prior to VAP rule changes in October 2019. The NFA letter could not be submitted last fall due to additional sampling being required last year and early this year prior to the NFA letter being submitted for the property. In addition, budget overages were incurred to prepare a technical assistance memorandum and related communication with Ohio EPA in preparation for the NFA submittal. This task order will complete the city's financial commitment for the east side of the Q3 JMC Property Redevelopment. This expense will be charged to the General Fund Miscellaneous Non-Departmental and is not in the 2020 budget (see attached). VOTE: 3-0

Ms. Boettcher stated that this budget represents the tax budget, the revenue side. She added that this Ordinance would have three readings to Council. She also stated that the budget is due to the County Auditor by July 20, 2020. She further went into some detail of the General Fund, stating that the estimate for 2021, is in the amount of \$7,039,000.00. She also advised Council that this was a copy and paste effort due to the fact that no one truly knows what is coming down the road, due to the pandemic. Further she went on to explain the expenses in the amount of \$7,001,890, was also a copy and past effort. Additionally, the Police/Fire Levy for 2021 is in the amount of \$115,000.00 in revenue. Also, the Governmental/Special Revenue is an estimated unencumbered fund in the amount of \$1,529,048.00.

President Hess asked how much property taxes would the City be receiving from the County. Ms. Boettcher advised \$516,300.00, to which would be split into two payments, the first being in March, and the second coming in August.

President Hess declared this Ordinance to have its first reading.

MISCELLANEOUS BUSINESS/WORK SESSION

Mr. Thackery asked if the paving was going to be completed this week. Mr. Brugger advised that it would all be wrapped up soon. Mr. Thackery also asked if there was any news on the Big Lots building. Mr. Brugger stated there was nothing confirmed.

Mr. Paul moved to excuse Councilman Hoffman. Mr. Thackery seconded. Voice vote on approval: all ayes; nays, none.

Motion passed 6-0.

Mr. Scott asked Ms. Boettcher if there was any feel for loss of tax revenue due to the pandemic. Ms. Boettcher stated that for the exception of the closure of Urbana University, most of the employees in the City have remained working. She added that there was a slight reduction in May, but there is a fair share of employers that withhold quarterly. She added that she would know more when July comes around.

Mr. Brugger stated that they were trying to wrap things up in the downtown area. He added that he is hoping the completion to be sometime in June. Mr. Paul asked if the delay was due to weather and Mr. Brugger chose not to respond. Mr. Brugger continued with advising that bids are due in on Friday for the AIP 2021 project. This would include extending the taxi lane all the way out to the main taxi way. He also spoke about nuisances and that the City has been very punctual on getting the case through to the Court. He added that the City is trying to keep things rolling that best way we can and he stated that he thought everyone was doing a fantastic job on their efforts to keep things rolling. He also stated that the hotel was scheduled to open in early June.

Mrs. Collier asked if shop owners downtown were allowed to have sidewalk sales. Mr. Brugger advised yes and that Mr. Crabill would be sending out a letter to downtown businesses advising them what they are allowed to do.

Mayor Bean said that this has been a tough battle dealing with the Covid-19 pandemic. He added that right now, there are only 10 people in this room, and changing our routine has been difficult but we have done it successfully thus far. He further stated that with a heavy heart, he wanted to touch on the topic of the tragedy with Mr. George Floyd. Further, he stated that here at the City, we are horrified about what happened up there. He added that he has spoken with Police Chief Lingrell and discussed what is necessary to keep doing what we can to keep our community safe. He added that the City of Urbana has one of the best police forces in the state and in the country. He stated that we all need to look to the future and mourn what has taken place in our country.

Mr. Fields stated that he heard that there would be some kind of protest or something of the sort on Saturday. Mr. Bean replied that he heard that there would be something located at Freedom Grove, but he wasn't sure what the plans were.

President Hess asked when the project comes up North Main Street (Laurel Oak), could they possibly vacate that street? Mr. Brugger stated there were thoughts of bringing the bike trail off/away from the railroad tracks and there is a possibility to incorporate that in with the project. President Hess also asked about the status of sidewalks/curbs project. Mr. Brugger advised that letters have been sent and should the sidewalks/curbs not be complete, the City would complete the project around the middle of June. President Hess also advised everyone to go down Hill Street.

Colin Stein made a motion to approve the meeting minutes from 10/10/2019 as prepared. Jim Lemon seconded the motion. All members in attendance voted (4-0) in favor of approving the minutes as prepared.

Old Business:

Possible Changes to Chapter 905 (Trees): During this meeting, members of the commission continued to review the most recent draft of the tree ordinance update. From this final review, the commission put together a list of bulleted items to consider as the final legislation was prepared. Doug Crabill shared that the first reading of the updated tree ordinance was planned for December 3, 2019.

Maintenance and Trimming Projects: Doug Crabill reported that additional tree trimming work will be required citywide during the winter months as weather permits.

Oakdale Cemetery-Arboretum Update: Doug Crabill again reported that his first focus was to get the tree ordinance revision completed before continuing work on the ArbNet application.

Arbor Day 2019-Urbana Elementary School (Recap): Doug Crabill reported that a tree planting ceremony was held at the new PreK-8 school in observance of Arbor Day on Friday, November 8, 2019 with 2nd graders participating in the program/tree planting ceremony. This celebration was hosted in collaboration with the Urbana City School District, Urbana Rotary Club, and the Urbana Shade Tree Commission. Mayor Bill Bean delivered his Arbor Day proclamation again on November 8, 2019 to these students. The Urbana Rotary Club spearheaded a tree planting project on the new PreK-8 school campus which added forty-two (42) trees to the campus, and the final tree was planted by the 2nd grade students as part of the Arbor Day celebration on November 8th. The students planted a Winter King Hawthorn. As part of the Urbana Rotary Club's tree planting project, the following species were planted on the campus of the Urbana PreK-8 school: Winter King Hawthorn, Red Oak, Red Maple, and Flowering Dogwood. In addition, the Urbana Rotary

Club planted eight (8) trees at the new Urbana High School and five (5) trees at the Champaign County Fairgrounds.

Overage on Task 2 is primarily due to the completion of out of scope items including the writing, submittal and technical assistance participation directly related to the JMC portions of the December 2019 Technical Assistance Memorandum (est. 86% of the overage) as well as substantive changes to the Phase II report due to the October 2019 VAP rule revision (est. 14% of the overage). Many of the generic standards were changed although only slightly required revisions to both the Technical Memorandum and Phase II report text, all data summary tables, and figures representing exceedances of applicable standards. Task 2 is complete.

A RESOLUTION AUTHORIZING THE DIRECTOR OF ADMINISTRATION OF THE CITY OF URBANA. TO PREPARE AND SUBMIT FINAL APPLICATION TO PARTICIPATE IN THE FEDERAL AVIATION ADMINISTRATION (FAA) AIRPORT IMPROVEMENT PROGRAM (AIP) AND TO EXECUTE CONTRACTS AS REQUIRED. (Suspension of Rules requested)

WHEREAS, the Federal Aviation Administration provides grants to public agencies for public use airports in the form of the Airport Improvement Program (AIP): and

WHEREAS, the City of Urbana has developed a long-range plan for the continued improvement of the city owned general aviation airport, Grimes Field; and

WHEREAS, grant funds are available through the FAA Airport Improvement Program for 90% of eligible project costs contained in the long-range plan for Grimes Field: and

WHEREAS, additional grant funds are available through the FAA's Coronavirus Aid. Relief, and Economic Security (CARES) Act for the remaining 10% of eligible project costs contained in the 2020 project.

NOW THEREFORE, BE IT RESOLVED by the Council of the City of Urbana:

Section 1: That the Director of Administration, is hereby authorized to apply to the FAA for FY2020 FAA AIP funds (AIP-2020) to complete the scope of work required for construction of Taxiway "C", which will include the decommissioning of Taxiway "B". The estimated cost of the project is \$598,377.20, with the FAA AIP covering 90% of the cost (\$538,539.00) and the remaining 10% balance (\$59.838.20) being covered by the FAA CARES Act.

Section 2: That the Director of Administration, is further authorized to contract for any engineering and consulting services for the above-named project as be necessary for the application and administration of above noted grant program.

Section 3: That the Director of Administration and City of Urbana, Ohio shall agree to abide by the terms and conditions of accepting Airport Improvement Program Grants (and subsequent updates). These terms and conditions may be unilaterally amended by the FAA, by notification in writing, and such amendment will only apply to grants accepted after notification.

Section 4: That it is found and determined that all formal actions of this City Council concerning and relating to the passage of this ordinance were adopted in an open meeting of this City Council and of any of its committees that resulted in such formal actions were in meetings open to the public in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

ORDINANCE NO. 4523-20

AN ORDINANCE TO SUBMIT CITY CHARTER AMENDMENTS TO THE ELECTORS OF THE CITY OF URBANA.

WHEREAS, pursuant to the City Charter, §8.03, and the Constitution of the State of Ohio, the City Charter is to be reviewed in 1990 and every 10 years thereafter by a Charter Review Board; and

WHEREAS, any amendments or revisions to the Charter recommended by the Board is to be submitted to the electors in the manner prescribed by the Constitution of the State of Ohio; and

WHEREAS, Council is required to submit these recommendations to the City electors;

NOW, THEREFORE, BE IT ORDAINED BY THE URBANA CITY COUNCIL:

<u>Section 1:</u> That City Council authorizes and directs that the amendments to the City's Charter as set forth herein shall be submitted to the electors of the City, in the question form specified herein, to be voted upon on the day of the general election, to-wit: Tuesday, November 3, 2020.

<u>Section 2:</u> Shall Section 2.03 of the Charter of the City of Urbana, Ohio, be amended to delete the italicized language indicated in brackets?

SECTION 2.03. COMPENSATION.

Compensation for City officials and employees shall be established by ordinance of Council. This does not preclude the City administration from negotiating with City employee groups regarding wages and fringe benefits. [Any changes in the salaries of elected officials for the ensuing term shall be set at least 5 days prior to the last day for filing for candidacy and salaries may not be changed during the term.]

Section 3: Shall Section 2.06 of the Charter of the City of Urbana, Ohio, be amended to add the following italicized, capitalized language and to delete the italicized language indicated in brackets?

SECTION 2.06. VACANCIES.

If the office of president of Council becomes vacant, the president pro tempore shall also serve as acting president until a successor to the president of Council is nominated and elected as provided in Section 7.07. The President of Council shall not lose his status as a voting member of Council. While serving as acting president, the president pro tempore shall not lose his status as a voting member of the Council and he shall stand in line of succession to the office of Mayor. No vacancy in the Council shall be created by the president pro tempore serving as acting president. A vacancy in the office of the president pro tempore shall be filled by appointment of a Council member made by a majority vote of the remaining Council members. When the office of Council members becomes vacant, the vacancy shall [be filled

by election of a qualified person by a majority vote of remaining Council members in such a manner as prescribed by adopted rules of Council. If the Council shall fail within forty-five days of the occurrence of the vacancy to fill such vacancy, the President of Council shall fill it by appointment. The person elected by the Council or appointed by the President of Council shall serve until a successor is nominated and elected as provided in Section 7.07.] REMAIN OPEN UNTIL FILLED BY AN ELECTED PERSON AT THE NEXT ELECTION AT WHICH CANDIDATES MAY RUN IN COMPLIANCE WITH THE BOARD OF ELECTION TIME RESTRAINTS. THE NEWLY-ELECTED PERSON SHALL COMPLETE THE VACANT TERM.

<u>Section 4:</u> Shall Section 2.09 of the Charter of the City of Urbana, Ohio, be amended to delete the italicized language indicated in brackets?

SECTION 2.09. LEGISLATIVE PROCEDURE.

The legislative action of the Council shall be by ordinance or resolution, introduced in written form, which shall contain no more than one subject, which shall be expressed clearly in the title. Ordinances involving general appropriations may contain the various subjects and accounts for which monies are appropriated, and codification, recodifications and publications of ordinances and resolutions in book form may contain more than one subject. An affirmative vote of a majority of Council shall be required for the enactment of every ordinance or resolution, unless a larger number be required by the provisions of this Charter.

[Council shall pass no ordinance or resolution which adopts a position contrary to a recommendation of the Planning Commission, made within the scope of its authority, except by a vote of majority. Council may enact ordinances that supersede state statutory provisions with respect to acquisition and disposition of property upon a majority affirmative vote.]

<u>Section 5:</u> Shall Section 3.05 of the Charter of the City of Urbana, Ohio, be amended to add the following italicized, capitalized language and to delete the italicized language indicated in brackets?

SECTION 3.05 VACANCY.

In the event of a vacancy in the office of Mayor, the president of Council shall succeed to the office of Mayor to serve [the unexpired term.] UNTIL SAID OFFICE IS FILLED BY AN ELECTED PERSON AT THE NEXT ELECTION AT WHICH CANDIDATES MAY RUN IN COMPLIANCE WITH THE BOARD OF ELECTION TIME RESTRAINTS. THE NEWLY-ELECTED PERSON SHALL COMPLETE THE VACANT TERM.

Section 6: Shall Section 4.02 of the Charter of the City of Urbana, Ohio, be amended to add the following italicized, capitalized language?

SECTION 4.02. DIRECTOR OF LAW.

The Director of Law shall be appointed by the Mayor, subject to confirmation by the Council, and shall be admitted to practice law in the State of Ohio. REMOVAL OF THE DIRECTOR OF LAW MUST ALSO BE CONFIRMED BY COUNCIL.

<u>Section 7:</u> Shall Section 4.03 of the Charter of the City of Urbana, Ohio, be amended to add the following italicized, capitalized language?

SECTION 4.03. DIRECTOR OF FINANCE.

The Director of Finance shall be appointed by the Mayor, subject to confirmation by the Council, on the basis of his OR HER competence as demonstrated by experience, education or both. REMOVAL OF THE DIRECTOR OF FINANCE MUST ALSO BE CONFIRMED BY COUNCIL.

Section 8: Shall a subsection (k) be added to Section 4.06 of the Charter of the City of Urbana, Ohio, which subsection (k) would contain the following italicized, capitalized language?

(k) A SALARY COMMISSION IS HEREBY CREATED WHICH SHALL DETERMINE THE SALARIES OF THE MAYOR AND THE COUNCIL MEMBERS. THE SALARY COMMISSION SHALL CONSIST OF FIVE MEMBERS WHO ARE REGISTERED ELECTORS OF THE CITY APPOINTED BY THE MAYOR SUBJECT TO THE CONFIRMATION BY COUNCIL BY RESOLUTION. THE FIVE MEMBERS SHALL CONSIST OF ONE PERSON FROM EACH OF THE 4 WARDS IN THE CITY, AS WELL AS ONE AT-LARGE. THREE OF THE MEMBERS OF THE SALARY COMMISSION SHALL SERVE FOR TWO YEARS AND TWO FOR THREE YEARS, TO TAKE OFFICE WITHIN 30 DAYS AFTER THE EFFECTIVE DATE OF THIS SECTION. THEREAFTER, MEMBERS OF THE SALARY COMMISSION SHALL BE APPOINTED TO SERVE FOR THREE YEARS AND UNTIL THEIR SUCCESSORS HAVE BEEN APPOINTED AND HAVE QUALIFIED. NO COUNCIL MEMBER OR EMPLOYEE OF THE CITY OR MEMBERS OF THE IMMEDIATE FAMILY OF A COUNCIL MEMBER OR EMPLOYEE SHALL BE ELIGIBLE TO BE A MEMBER OF THE SALARY COMMISSION.

THE SALARY COMMISSION SHALL FROM TIME TO TIME ELECT A CHAIRPERSON FROM ITS MEMBERSHIP. WITHIN 45 DAYS OF ITS CREATION, AND EVERY ODD NUMBERED YEAR THEREAFTER, THE SALARY COMMISSION SHALL MEET TO CONSIDER THE SALARIES AND COMPENSATION OF THE MAYOR AND COUNCIL MEMBERS.

BEYOND THE TERMS CONTAINED HEREIN, THE RULES GOVERNING THE SALARY COMMISSION SHALL BE SET BY CITY COUNCIL.

Section 9: Shall Section 2.17 of the Charter of the City of Urbana, Ohio, be amended to add the following italicized, capitalized language?

SECTION 2.17. PUBLICATION OF ORDINANCES AND RESOLUTIONS.

At least once every 90 days, the Clerk of Council shall submit a list of legislation adopted by Council to a newspaper of general circulation AND/OR DIGITALLY within the City and post that list conspicuously in the City building and online. The list shall fairly describe and summarize the legislation enacted anD announce that the full text of Ordinances and Resolutions are available for inspection at the office of the Clerk of Council, or the full text may be provided by a digital or hard copy upon request to the Clerk. Failure of publication, or any error or omission in publication, shall not invalidate an Ordinance or Resolution.

The City shall not be required to advertise through paid publication except to comply with Ohio Revised Code Section 705.16(B), which requires legal advertising in a newspaper of general circulation only once upon adoption for a legislation of a permanent general nature, or providing for public improvements, or assessing property in the municipal corporation.

Section 10: The Clerk of Council is directed to publish the full text of the proposed charter amendment in accordance with Section 9 of Article XVII of the Ohio Constitution, and Ohio R.C. §§731.211 and 7.16. Said publication shall take place once a week for not less than two consecutive weeks in the Urbana Daily Citizen, with the first publication being at least fifteen days prior to the election at which the amendment is to be submitted to the electors, to-wit: the general election to be held on November 3, 2020.

Section 11: Formal actions of this City Council concerning and relating to the passage of this Ordinance were adopted in open meeting in compliance with all legal requirements including Ohio R.C. §121.22 and Urbana Codified Ordinances, §107.01.

<u>Section 12:</u> This Ordinance shall take effect at the earliest time provided by law. If the electors of the City enact any particular provisions proposed by this Ordinance, the effective date of those Charter amendments shall be January 1, 2021.
