Dear Property Owner:

City Council passed Resolution #2582-20 on May 5, 2020 mandating replacement of certain sections of deficient sidewalks, curbs and/or gutters in the City of Urbana. A certified copy of the legislation is attached. You are receiving this notice because, according to the Champaign County Auditor's records, you own lot(s) or land(s) abutting the designated sections of street for which repairs have been identified and these repairs were not complete as of April 29, 2020. The original notice under Urbana Code Section 913 was sent to property owners on January 28, 2020, establishing the aforementioned April 2020 deadline.

As a property owner, you are responsible for the maintenance of your sidewalks, curbs and gutters according to City Code 913.03. Furthermore, Council through Ohio Revised Code 729 is granted the special power to require the construction or repair of sidewalks, curbs and/or gutters and levy an assessment against the lots or lands abutting if the required action is left undone.

Therefore, you are advised that you have until June 8, 2020 to complete the repairs. If you choose not to, the City will pay to have them done and bill you for the work (with no additional City fees). If unpaid, the cost will be added as an assessment to the property tax bill collected over 5 years. The Auditor may add a fee for processing this assessment.

Sections of sidewalks, curbs and/or gutters have been marked in white at your location. These require replacement. An address listing with corresponding estimated quantities is on file along with plans, specifications and an overall cost estimate at the offices of the Clerk of Council and City Engineer at 205 S. Main Street, Urbana, Ohio 43078.

If you choose to do the work, please complete and turn in the attached right-of-way work permit with your chosen contractor's information listed. There is a \$50.00 fee associated with this permit. All replacements and restorations must be made per the plans and specifications on file by the deadline of *June 8, 2020*.

Resolution #2582-20

DECLARING THE NECESSITY OF CONSTRUCTING OR REPAIRING SIDEWALKS, CURBS AND GUTTERS, AND DECLARING AN EMERGENCY.

WHEREAS, Section 729.01 of the Ohio Revised Code grants this Council the special power to require the construction or repair of sidewalks, curbs or gutters by the owners of lots or lands abutting thereon and to prescribe the time in which such construction or repair must be completed; and

WHEREAS, Section 729.02 of the Ohio Revised Code states that when it is deemed necessary by this Council to require the construction or repair of sidewalks, curbs or gutters within the City, it shall cause plans, specifications and an estimate of the cost of such construction or repair to be prepared and filed in the office of the Clerk; and

WHEREAS, in accordance with Section 729.01 of the Ohio Revised Code, this Council finds it necessary to require the construction or repair of sidewalks, curbs or gutters within the City; and

WHEREAS, the plans, specifications and estimate of cost have been filed with the Clerk of Council, as required by Section 729.02 of the Ohio Revised Code; and

WHEREAS, Section 729.02 of the Ohio Revised Code further states that upon such filing, this Council may declare the necessity for the construction or repair of such sidewalks, curbs or gutters by the passage of a resolution.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Urbana, Ohio, a majority of the members of Council present concurring, that:

Section 1. It is hereby declared necessary for the preservation of the public health, safety and welfare of the City of Urbana, Ohio, to construct or repair certain sidewalks, curbs and/or gutters in the City of Urbana at the following locations:

- a) Scioto Street, from Locust Street to the E. US Highway 36/E. SR 29 split
- b) East Lawn Avenue, from Scioto Street to Bloomfield Avenue/Mark Drive
- c) Finch Street, from Scioto Street to E. Water Street/Amherst Drive
- d) Ames Avenue, from Scioto Street to Amherst Drive
- e) East Water Street, from South Main Street to Finch Street
- f) South Kenton Street, from Scioto Street to East Market Street

<u>Section 2</u>. The plans, specifications and estimate of cost of the proposed construction or repair, now on file in the office of the Clerk, are hereby approved.

Section 3. The owner(s) of each lot and parcel of land bounding and abutting on such sidewalks, curbs and/or gutters shall construct or repair that portion of the sidewalks,

curbs and/or gutters which abut his or her property, in accordance with the plans and specifications on file in the office of the Clerk of Council.

<u>Section 4</u>. Such sidewalks, curbs and/or gutters shall be constructed or repaired by the owner(s) of the lots and lands abutting thereon no later than June 8, 2020.

<u>Section 5</u>. In the event any such abutting property owner does not complete the required construction or repair of that portion of such sidewalks, curbs and/or gutters which abut his or her property in accordance with the plans and specifications and within the time prescribed by this Resolution, this Council will cause the construction or repair to be done and will assess the cost thereof against the lots and lands abutting thereon.

Section 6. The Clerk of Council, or his or her designee, is hereby directed to serve notice of the passage of this Resolution on the owners of the lots and lands abutting on the sidewalks, curbs and/or gutters to be constructed or repaired in accordance with Ohio Revised Code Section 729.03.

Section 7. It is found that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council that resulted in this formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code, and the Rules of Council.

Section 8. This Resolution is hereby declared an emergency measure as it relates to addressing public health, safety and welfare and shall become effective immediately upon its passage.

BZA-2020-001 - 170 State Route 55 - Urbana Hotel LLC

Case # 1:

Variance from the Urbana Corridor Overlay Sign Standards to allow the applicant to place three wall signs on the structure, which is one more than allowed by code.

Application:

Lisa Haulman read the application to the Board.

Staff Comments

Recommendations:

Cat Tanujaya provided the background and read the staff report to the Board.

Testimony in Favor:

Luke Putterbaugh (Urbana Hotel LLC) - Since the hotel is on a corner lot, on an angle, it's imperative to have

sign visibility in all directions.

Testimony Against:

None.

Discussion:

Bryant Heflin – No issue or questions with the request. Mr. Heflin understood the need for the additional sign since the hotel is at an angle. The sign is also within the code requirement.

Charlie Zerkle – One of the sides is blocked by the dentist office and that limits visibility. Is it necessary to have a sign on that side? When you drive past the dentist office, you're able to see the entire hotel. There



was a case with Wendy's where they made a similar request to have three wall signs.

Skip Mintchell – The position and placement of the hotel is ideal for visibility from all three areas. The side towards US Highway 68 is also in a good position where it doesn't affect the neighborhood, which was a main concern.

Lisa Haulman – Agrees with Skip and was concern with the intensity of the light affecting the surrounding houses and apartments. It doesn't seem like that would be a problem. It is similar to the request from Wendy's, however in this regards, it wouldn't look right without the third sign.

Doug Crabill mentioned that the difference with Wendy's is that there's a monument sign already present and they wanted to add wall signs, while the only sign the Cobblestone will have is the 3 wall signs on the cupola. Luke Putterbaugh (Urbana Hotel LLC) explained that the height and size of the sign will not look very big or out of proposition since it will be in the distance. Ms. Haulman agreed that at first, an 8'x6' sign is very big, however when it's set on the cupola, it will look fine.

Marty Hess -

- What is the maximum face allowed on the wall sign?
 - o Mr. Heflin The maximum area per sign face is 75 square feet. The three wall signs would total about less than 150 square feet which is still below the 225 square feet allowed. Mr. Heflin also agrees that the distance and the height are reasonable for the sign of that size.
 - Mr. Crabill The minimum area per sign face is 25 square feet. Typically there's a maximum allowed per site and this request is well below the maximum limit.

Charlie Zerkle -

- Is there a possibility that in the future there will be a request for a monument sign?
 - Mr. Putterbaugh Is unable to answer that question.
 - Mr. Crabill Clarified that during the planning process that question was raised and there
 is no intention for a monument sign. The only signage will be on the cupola.
- What happens if that request does come through in the future?
 - Mr. Crabill They will be allowed to have a monument sign without the BZA approval as long as it meets the sign code requirements for monument sign.

Marty Hess -

- How bright will the signs be?
 - Mr. Putterbaugh For the size, height and distance of the sign, it won't be any different than a parking lot light. The signs will be very high up that they will not be any brighter than other signs seen around Urbana.
 - Mr. Mintchell The only sign in the area is the Erin Patton State Farm sign but there are no other sign in the area for comparison.
 - Mr. Crabill Explained that the signs will be internally lit and it will look like it glows instead of shining out.

Bryant Heflin -

- Is the third wall sign request for the one facing US Highway 68?
 - o Mr. Putterbaugh Is unable to answer that question because the plan he received is to have three wall signs installed and does not know which one is the extra one.
 - O Mr. Heflin According to the application the west facing sign is good for visibility on State Route 55, so that extra sign is on the left side. If you look at the hotel placement, it makes sense.



Marty Hess -

• Does every Cobblestone have this signage?

o Mr. Putterbaugh – Yes, he believes that it's the standard.

Resolution No. 2588-20 AUTHORIZING LEGISLATION

A RESOLUTION OF SUPPORT AND LOCAL MATCH COMMITMENT FOR THE CITY OF URBANA'S SHARE FOR THE REPAVING OF DELLINGER ROAD AS PART OF A LARGER MULTI-JURISDICTIONAL PROJECT KNOWN AS DELLINGER, MIDDLE URBANA, AND THREE MILE PAVING, AND DECLARING AN EMERGENCY.

WHEREAS, the Champaign County Engineer is working with the City of Urbana, Salem Township, and Urbana Township on a larger multi-jurisdictional project to resurface Dellinger Road within the City of Urbana and Salem Township and to resurface portions of Middle Urbana Road and Three Mile Road in Urbana Township; and

WHEREAS, the Ohio Public Works Commission is now soliciting grant applications for Round 35 (State Fiscal Year 2022) from local government jurisdictions in anticipation of future state funding being allocated to the State Capital Improvement Program and/or Local Transportation Improvement Program(s) by the state legislature; and

WHEREAS, the City of Urbana, Salem Township, and Urbana Township have identified paving projects within their jurisdictions to be put together collectively as one grant application and project with the Champaign County Engineer making the application to the Ohio Public Works Commission on behalf of these jurisdictions; and

WHEREAS, a local match is required for this project from the jurisdictions involved in this project; and

WHEREAS, if this larger multi-jurisdictional project is awarded grant funding by the Ohio Public Works Commission, construction is anticipated in either the fall of 2021 or the spring of 2022; and

WHEREAS, the infrastructure improvement herein above described is considered to be a priority need for the community and is a qualified project under the OPWC programs.

NOW THEREFORE, BE IT RESOLVED by the Council of the City of Urbana, Ohio:

Section 1: That the Urbana City Council and the City of Urbana fully support the Champaign County Engineer's multi-jurisdictional grant application to the Ohio Public Works Commission to improve multiple roads within the county, including Dellinger Road which is maintained by both the City of Urbana and Salem Township.

Section 2: That the Urbana City Council and the City of Urbana fully commit to provide the required local match for the city's portion of this project through the necessary budget appropriation in the year when the project is to be completed, including in-kind inspection services and up to one third of the cost of bid advertising for the larger multijurisdictional project.

Section 3: That this resolution shall take effect and be in force immediately upon passage to ensure the timely submission of this grant submission in order to improve an existing roadway for the motoring public.

Ordinance #4525-20

AN ORDINANCE LEVYING SPECIAL ASSESSMENTS FOR THE PURPOSE OF CONSTRUCTING OR REPAIRING SIDEWALKS, CURBS AND GUTTERS, AND DECLARING AN EMERGENCY

WHEREAS, Council on May 5, 2020 adopted Resolution #2582-20 declaring it necessary to construct or repair certain designated sidewalks, curbs and/or gutters and the notice of passage of such Resolution was given to affected property owners as required by law; and

WHEREAS, the City of Urbana has subsequently constructed those designated sidewalks, curbs and/or gutters in various locations in the City, where such were not constructed by the owners of the property abutting thereon; and

WHEREAS, a list of the estimated assessments of the total cost of said construction has been prepared, placed on file in the office of the clerk of the Urbana City Council and published as required by law; and

WHEREAS, the Council has duly reviewed and considered all objections filed, if any, with respect to said estimated assessments and has made such changes and corrections thereto as it determines to be proper;

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Urbana, Ohio, a majority of the members of Council present concurring, that:

<u>Section 1</u>. That the list of estimated assessments of the cost of constructing certain sidewalks, curbs and/or gutters in various locations in the City of Urbana, Ohio as provided for in Resolution #2582-20, heretofore reported to this Council and now filed in the office of the clerk of the Urbana City Council, attached hereto as Exhibit A, aggregating in the amount of \$48,521.84, and the same hereby adopted and confirmed.

<u>Section 2</u>. That the amounts of the aforesaid assessments, subject to the conditions of Section 4 below, shall hereby be assessed and levied upon the lots and lands abounding and abutting said improvements.

<u>Section 3</u>. That it is hereby determined that aforesaid assessments do not exceed the special benefits resulting from said improvements and do not exceed any statutory limitation.

<u>Section 4</u>. That the number of properties, shown in Exhibit A, to be assessed may hereby be reduced upon owner's full payment in cash to the Director of Finance of the City on or before September 4, 2020.

<u>Section 5</u>. That the clerk of the Urbana City Council be and is hereby authorized and directed to continue on file in her office a list of said assessments and the description of said lots and lands.

<u>Section 6</u>. That the total assessment against each lot and parcel of land shall be payable in cash to the Director of Finance of the City on or before September 4, 2020, or the assessment, or the unpaid balance thereof, shall be certified by the clerk of the Urbana City Council to the County Auditor on or before September 8, 2020, to be placed by the Auditor on the respective tax duplicate and collected in five (5) annual installments with interest thereon at 0% per annum at the same time and in the same manner as other taxes are collected, as provided by law.

<u>Section 7</u>. That the clerk of the Urbana City Council is hereby authorized and directed to cause notice of passage of this Ordinance to be published in the manner provided by law.

<u>Section 8</u>. It is found that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council that resulted in this formal action were in meetings open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code, and the Rules of Council.

<u>Section 9</u>. This Ordinance is hereby declared an emergency measure as it relates to addressing public health, safety and welfare and shall become effective immediately upon its passage.
