

**Public Notice
Advertisement for Bids**

Sealed bids will be received at the Office of the City Engineer of the City of Urbana, 205 South Main Street, Urbana, Ohio 43078, until 10:00AM local time, August 20, 2013, to furnish all labor, materials, and equipment necessary to complete the project known as "Dellinger Road Improvements", and at said time and place, be publicly opened and read aloud. This is a cooperative project between the City of Urbana and Salem Township, and the project encompasses the cutting down of an existing hill, 800' of sanitary sewer extension, and asphalt and driveway repair and/or replacement.

Engineer's Estimate: \$342,666.00

The proposals shall be made on the forms provided in the Contract Documents or a copy thereof and shall contain the full name and address of the bidder. All bids shall be sealed and plainly marked "Dellinger Road Improvements".

Bids shall be submitted in **duplicate**, signed and submitted on the separate bidding forms included in the Bidding Documents, and shall be accompanied by either a Bid Guaranty Bond issued in favor of the City of Urbana, Ohio and Salem Township, Champaign County, Ohio in the amount of 100% of the Bid amount or by a certified check, cashier's check, or letter of credit on a solvent bank in the amount of not less than 10% of the amount of the Bid, subject to conditions provided in the Instructions to Bidders. The successful BIDDER will be required to furnish a satisfactory Performance Bond in favor of the City of Urbana, Ohio and Salem Township, Champaign County, Ohio in the amount of 100% of the Bid in accordance with Section 153.54 of the Ohio Revised Code.

Each Bid must contain the full name of the party or parties submitting the Bid and all persons interested therein. Each BIDDER must submit evidence of its experiences on projects of similar size and complexity. The owner intends that construction will begin by mid-September 2013 and requires that this project be substantially completed by November 29, 2013.

All contractors and subcontractors involved with the project will, to the extent practicable use Ohio products, materials, services, and labor in the implementation of their project. Additionally, contractor compliance with the equal employment opportunity requirements of Ohio Administrative Code Chapter 123, the Governor's Executive Order of 1972, and Governor's Executive Order 84-9 shall be required.

Each prospective bidder shall be a plan holder of record with the City of Urbana Engineer's Office in order to submit a bid for this project.

The contractor and all subcontractors shall pay employees on the project the prevailing wages established by the Ohio Department of Commerce, Bureau of Labor and Worker Safety, including all updates, and shall comply with the provisions of Chapter 4115 of the Ohio Revised Code. The current Prevailing Wage Rate Schedule is included in the bid documents.

A valid workers' compensation certificate shall be provided upon contract award to the successful bidder.

A valid certificate of insurance in accordance with the bid documents issued to the City of Urbana and Salem Township, Champaign County, Ohio shall be provided upon contract award to the successful bidder.

No bids shall be withdrawn for a period of sixty (60) days after the opening thereof.

The Owner reserves the right to reject any or all bids, waive irregularities in any Bid and to accept any Bid which is deemed by the Owner to be most favorable to the Owner.
