

## **PUBLIC NOTICE**

### **Advertisement for Bids**

Sealed bids will be received at the Office of the City Engineer of the City of Urbana, 205 South Main Street, Urbana, OH 43078, until 2:00 p.m., Tuesday, January 6, 2015, for furnishing of all labor, materials, and equipment necessary to complete the project known as the "West Market Street Bridge Replacement", and at said time and place, be publicly opened and read aloud. The project encompasses the replacement of the existing jack-arch bridge on West Market Street with one new box culvert, concrete wing walls, railing, utility replacement, asphalt restoration, sidewalk, curb and gutter, etc.

Engineer's Estimate: \$165,000.00

The proposals must be submitted on the forms provided in the Contract Documents or a copy thereof and shall contain the full name and address of the bidder. All bids shall be sealed and plainly marked "West Market Street Bridge Replacement".

Bids shall be submitted in **duplicate**, signed and submitted on the separate bidding forms included in the Bidding Documents, and shall be accompanied by either a Bid Guaranty Bond issued in favor of the City of Urbana, Ohio and the Ohio Department of Transportation in the amount of 100% of the Bid amount or by a certified check, cashier's check, or letter of credit on a solvent bank in the amount of not less than 10% of the amount of the Bid, subject to conditions provided in the Instructions to Bidders. The successful BIDDER will be required to furnish a satisfactory Performance Bond in favor of the City of Urbana, Ohio and the Ohio Department of Transportation in the amount of 100% of the Bid in accordance with Section 153.54 of the Ohio Revised Code.

Bidders shall be Ohio Department of Transportation (ODOT) prequalified in order to submit a bid for this project. The "prime" contractor shall be (ODOT) prequalified in Work Type #20 (Level 1 Bridge). Prequalification status shall be in force at the time of bidding, the time of sale, the time of award, and through the life of the construction contract. Subcontractors are not subject to the prequalification requirement. The "prime" contractor shall not perform less than 30 percent of the total original contract price.

The project is funded with Federal Highway Administration funds. Therefore, this project shall be a prevailing wage contract in accordance with Federal Labor Standards Provisions and Davis-Bacon Wage Laws. Attention of the bidder is called to the various insurance requirements and various equal opportunity provisions.

Each Bid must contain the full name of the party or parties submitting the Bid and all persons interested therein. Each BIDDER must submit evidence of its experiences on projects of similar size and complexity. The owner intends that this project will be awarded no later than January 29, 2015 and requires that this project be completed and ready for final payment no later than September 22, 2015.
