Sealed bids will be received at the Office of the Board of Champaign County Commissioners, 1512 South U.S. 68, Suite A100, Urbana, Ohio 43078, until 10:00AM local time, Tuesday, September 29, 2015 to furnish all labor, materials, and equipment necessary to complete the project known as Champaign County CDBG FY2014 – City of Urbana Taft Avenue Improvements (Rebid) and at said time and place, be publicly opened and read aloud. The project consists of pavement planning, asphalt resurfacing of existing pavement, curb ramps, and related work items on Taft Avenue.

**Engineer’s Estimate: \$86,000.00**

The proposals shall be made on the forms provided in the Contract Documents or a copy thereof and shall be contain the full name and address of the bidder. All bids shall be sealed and plainly marked “Champaign County CDBG FY2014 – City of Urbana Taft Avenue Improvements (Rebid)”.

Bids shall be submitted in duplicate, signed and submitted on the separate bidding forms included in the Bidding Documents, and shall be accompanied by either a Bid Guaranty Bond in the amount of 100% of the Bid amount or by a certified check, cashier’s check, or letter of credit on a solvent bank in the amount of not less than 10% of the amount of the Bid, subject to conditions provided in the Instructions to Bidders. The successful BIDDER will be required to furnish a satisfactory Performance Bond in the amount of 100% of the Bid in accordance with Section 153.54 of the Ohio Revised Code.
