Advertisement for Bids**

Sealed bids will be received at the Office of the City Engineer of the City of Urbana, 205 South Main Street, Urbana, OH 43078, until 10:00 a.m. local time, Tuesday, February 2, 2016, to furnish all labor, materials, and equipment necessary to complete the project known as 2016 Asphalt Program, and at said time and place, be publicly opened and read aloud.

Engineer's Estimate for Base Bid: \$317,000.00
Engineer's Estimate for Additive Bid #1: \$7,581.70
Engineer's Estimate for Additive Bid #2: \$13,920.04
Engineer's Estimate for Additive Bid #3: \$8,106.12

The proposals shall be made on the forms provided in the Bidding Documents or a copy thereof and shall contain the full name and address of the bidder. All bids shall be sealed and plainly marked "2016 Asphalt Program".

Bids shall be submitted in **duplicate**, signed and submitted on the separate bidding forms included in the Bidding Documents, and shall be accompanied by either a Bid Guaranty Bond in the amount of 100% of the gross Bid amount (base+additives) or by a certified check, cashier's check, or letter of credit on a solvent bank in the amount of not less than 10% of the amount of the gross Bid amount (base+additives), subject to conditions provided in the Instructions to Bidders. The successful bidder will be required to furnish a satisfactory Performance Bond in the amount of 100% of the gross Bid amount (base+additives) in accordance with Section 153.54 of the Ohio Revised Code.

The contractor and all subcontractors shall pay employees on the project the prevailing wages established by the Ohio Department of Commerce, Bureau of Labor and Worker Safety, including all updates, and shall comply with the provisions of Chapter 4115 of the Ohio Revised Code. The current Prevailing Wage Rate Schedule is included in the bid documents.
