Advertisement for Bids**

Sealed bids will be received at the Office of the Board of Champaign County Commissioners, 1512 South U.S. 68, Suite A100, Urbana, Ohio 43078, until 10:00AM local time, Tuesday, November 27, 2018 to furnish all labor, materials, and equipment necessary to complete the project known as Champaign County CDBG FY2017 - North Oakland Street Curbs & Walks (Phase 3) at said time and place, be publicly opened and read aloud. The project consists of the replacement of 232 square yards of 6" plain concrete pavement for drive approaches; 11,644 square feet of 4" concrete walk (sidewalk); 3,406 lineal feet of combination curb and gutter, and 12 catch basins along six blocks of North Oakland Street in the City of Urbana, OH.

Engineer's Estimate: \$330,000.00

The proposals shall be made on the forms provided in the Contract Documents or a copy thereof and shall contain the full name and address of the bidder. All bids shall be sealed and plainly marked "Champaign County CDBG FY2017 – North Oakland Street Curbs and Walks (Phase 3)".

Bids shall be submitted in duplicate, signed and submitted on the separate bidding forms included in the Bidding Documents, and shall be accompanied by either a Bid Guaranty Bond in the amount of 100% of the Bid amount or by a certified check, cashier's check, or letter of credit on a solvent bank in the amount of not less than 10% of the amount of the Bid, subject to conditions provided in the Instructions to Bidders. The successful BIDDER will be required to furnish a satisfactory Performance Bond in the amount of 100% of the Bid in accordance with Section 153.54 of the Ohio Revised Code.

No bids shall be withdrawn for a period of sixty (60) days after the opening thereof. Project completion date shall be Friday, June 28, 2019.

This project is funded with Community Development Block Grant funds. Therefore, this project shall be a prevailing wage project contract in accordance with federal Davis-Bacon Wage Laws. Bidders shall comply with all applicable provisions of the federal prevailing wage laws. This project is also subject to all applicable Federal Equal Employment Opportunity laws and Federal Labor Standards.
