

PUBLIC NOTICE

Advertisement for Bids

Sealed bids will be received at the Office of the City Engineer of the City of Urbana, 205 South Main Street, Urbana, OH 43078, until 1:00 p.m., Thursday, February 2, 2012, for furnishing of all labor, materials, and equipment necessary to complete the project known as the "Urbana Safe Routes to School, Phase 1", and at said time and place, be publicly opened and read aloud. The project encompasses the installation of sidewalk, curb ramps, striping, and flashing school zone signage.

Engineer's Estimate: \$433,000.00

The proposals must be submitted on the forms provided in the Contract Documents or a copy thereof and shall contain the full name and address of the bidder. All bids shall be sealed and plainly marked "Urbana Safe Routes to School, Phase 1".

Bids shall be submitted in **duplicate**, signed and submitted on the separate bidding forms included in the Bidding Documents, and shall be accompanied by either a Bid Guaranty Bond in the amount of 100% of the Bid amount or by a certified check, cashier's check, or letter of credit on a solvent bank in the amount of not less than 10% of the amount of the Bid, subject to conditions provided in the Instructions to Bidders. The successful BIDDER will be required to furnish a satisfactory Performance Bond in the amount of 100% of the Bid in accordance with Section 153.54 of the Ohio Revised Code.

Bidders shall be Ohio Department of Transportation (ODOT) prequalified in order to submit a bid for this project. Prequalification status shall be in force at the time of bidding, the time of sale, the time of award, and through the life of the construction contract. Subcontractors are not subject to the prequalification requirement. The "prime" contractor shall not perform less than 35 percent of the total original contract price.

The project is funded with Federal Highway Administration funds. Therefore, this project shall be a prevailing wage contract in accordance with Federal Labor Standards Provisions and Davis-Bacon Wage Laws. Attention of the bidder is called to the various insurance requirements and various equal opportunity provisions.

Each Bid must contain the full name of the party or parties submitting the Bid and all persons interested therein. Each BIDDER must submit evidence of its experiences on projects of similar size and complexity. The owner intends that this project will be awarded no later than March 9, 2012 and requires that this project be completed and ready for final payment no later than July 15, 2012.

Each prospective bidder shall be a plan holder of record with the City of Urbana Engineer's Office in order to submit a bid for this project.

No bids shall be withdrawn for a period of sixty (60) days after the opening thereof.

The Owner reserves the right to reject any or all bids, waive irregularities in any Bid and to accept any Bid which is deemed by the Owner to be most favorable to the Owner.
